The whole Governing Body

- Responsible for raising school standards
- Set strategic direction of the academy
- Ensure accountability:
- Monitor attainment and progress. Challenge and support where required
- · Monitorcurriculumso it stays broad and balanced
- Ensure professional development of staff
- Act as a 'critical friend'. Use our own skills and judgement to provide an independent view
- Oversee appointment of staff, staff performance and pay
- Review the effectiveness of the school's Behaviour Policy
- · Review school policies
- Ensure the school's complaints policy is being used effectively
- · Carry out annual safeguarding audit

- Ensure that the academy manages within its budget and takes steps to plan to generate income
- Develop strategic partnerships with other schools
- Develop strategic partnerships and innovations for the benefit of education, the community and the academy

- Attend weekday evening meetings, twice a term for the Full board & once a term for committee working party meetings
- Attend Trustees' Open Days, a chance to see the school in action
- Meet with subject leaders for Link Trustee reports
- Attend events to represent the Board of Trustees
