The whole Governing Body:

- Responsible for raising school standards
- Set strategic direction of the academy Ensure accountability:

- Monitor curriculum so it stays broad and balances
- Ensure professional development of staff
- Act as 'critical friend'. Use our own skills and judgement to provide an independent view
- Oversee appointment of staff, staff performance and pay
- Review the effectiveness of the school's Behaviour Policy
- Review school policies
- Ensure the school's complaints policy is being used effectively
- Carry out annual safeguarding audit
- Ensure the academy manages within its budget and takes steps to plan to generate income
- Develop strategic partnerships with other schools
- Develop strategic partnerships and innovations for the benefit of education, the community and academy

What do we do?

- Attend weekday evening meetings (5 times per year for the full governing body and once per term for committee meetings)
- Attend triangulation monitoring visits – intent, implementation and impact
- Attend events to represent the Board of Trustees
